Georgetown South Service Expansion and Union-Pearson Rail Link Project

>>> Proiect

In November 2008, Metrolinx adopted *The Big Move*, the Regional Transportation Plan for the Greater Toronto and Hamilton Area (GTHA). The Georgetown South Service Expansion and the Union-Pearson Rail Link, which would operate on the Georgetown Line, is the first major project to be initiated under *The Big Move*. The project would make it easier to get around the region by rail, generate 10,000 construction jobs, spur economic growth for businesses and communities in the GTHA, ease the social, environmental, and economic burdens of congestion, and reduce air pollution from cars.

Metrolinx is proposing to increase rail capacity between Bathurst Street in Toronto and Highway 427 in Peel Region to address GO Transit's operating needs. (Please see map). Metrolinx proposes to lay new tracks, build new and re-build existing stations and platforms along with bridges and underpasses to separate trains from other traffic. A passenger Rail Link would run on the corridor between Union Station and Lester B. Pearson International Airport. The Union-Pearson service would operate entirely on GO tracks except for a 3.3 kilometre track between Terminal 1 at Pearson Airport and the Georgetown Line.

>>> Process

The project's environmental impact will be assessed under Ontario's Transit Project Assessment Process (Regulation 231/08 under Ontario's Environmental Assessment Act). Regulation 231/08 assumes that the rationale and alternatives to public transit or the rationale and alternatives to this particular transit project have been established. The regulation, instead, allows the proponent, Metrolinx, to focus its efforts on the environmental and other impacts of the preferred method.

Metrolinx will prepare a draft Environmental Project Report. Two draft reports will be published. A copy of the first document may be downloaded from the Metrolinx's web site on April 14, 2009. The second document will be available in May 2009.

The first draft report will identify the site of the project and describe current environmental conditions, and present the preferred method. The second draft report will outline the impacts of the preferred method on the natural and built environments, economy and society and their interrelationships. It will describe measures which are being proposed to mitigate negative impacts and identify how the effectiveness of those measures will be checked. The two draft reports will be combined with the feedback Metrolinx receives from the public, government agencies, and First Nations to produce the Environmental Project Report.

The Environmental Project Report will be issued at the same time as the Notice of Completion. Anyone who received a Notice of Commencement or who registered with Metrolinx will receive a copy of the Notice of Completion.

Interested persons, government agencies, and First Nations will have 30 days to review the Environmental Project Report and send their comments in writing to the Minister of the Environment.

The Minister will have 35 days to review the comments and determine whether the project can proceed as described in the Environmental Project Report, proceed subject to conditions, or requires further work.

All comments received will become part of the public record for this project.

>>> Get Involved - Community Open Houses

This Notice of Commencement marks the beginning of the formal 120-day consultation period which will end when the Notice of Completion is issued.

As part of the formal consultation process, Metrolinx will host two rounds of Open Houses. The first round will share information on current environmental conditions and the scope of the preferred project, as well as identify changes as a result of public input.

Residents are encouraged to drop in, view the materials on display, and speak to the technical team to learn more.
